

## **END-USER LICENSE AGREEMENT FOR MACROEXPRESSIONS SOFTWARE PRODUCT**

**IMPORTANT-READ CAREFULLY:** This MacroExpressions End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and MacroExpressions for the software product accompanying this EULA, which includes computer software and electronic documentation. By installing, copying, or otherwise using the software product, you agree to be bound by the terms of this EULA. If you do not agree to the terms of this EULA, do not install, copy, or otherwise use software product; you may, however, return it to MacroExpressions for a full refund.

### **SOFTWARE PRODUCT LICENSE**

The software product is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The software product is licensed, not sold.

### **DEFINITIONS**

For the purpose of this EULA, “the software product” may mean Unimal, C-SLang and/or Snob, according to the actual accompanying product(s). The terms of this EULA are uniform.

## **1. LICENSE TO USE SOFTWARE PRODUCT**

**1.1 Evaluation License Grant.** MacroExpressions grants to you as an individual a non-exclusive license with the full power of General License, except that without obtaining General License neither you nor your entity can distribute in any way any product that incorporates, directly or indirectly, any output of the software product under Evaluation License or any result of further processing of such output.

**1.2 General License Grant.** MacroExpressions grants to you as an individual, a personal, nonexclusive license to make and use copies of the software product for the sole purposes of designing, developing, and testing your software product(s). You may install copies of the software product on an unlimited number of computers provided that you are the only individual using the software product. If you are an entity, MacroExpressions grants you the right to designate one individual within your organization to have the sole right to use the software product in the manner provided above.

**1.3 Documentation.** This EULA grants you, as an individual, a personal, nonexclusive license to make and use an unlimited number of copies of any documentation without restrictions.

**1.4 Storage/Network Use.** You may also store or install a copy of the software product on a storage device, such as a network server, used only to install or run the software product on computers used by a licensed end user in accordance with Section 1.1. A single license for the software product may not be shared or used concurrently by other end users.

## **2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS**

**2.1 Limitations on Reverse Engineering, Decompilation, and Disassembly.** You may not reverse engineer, decompile, or disassemble the software product, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

**2.2 Rental.** You may not rent, lease, or lend the software product.

**2.3 Support Services.** MacroExpressions will provide you with reasonable support services related to the software product for a period of one year from the date of delivery. With respect to technical information you provide to MacroExpressions as part of the Support Services, MacroExpressions may use such information for its business purposes, including for product support and development. MacroExpressions will not utilize such technical information in a form that personally identifies you.

**2.4 Software Transfer.** The initial user of the software product may make a one-time permanent transfer of this EULA and the software product only directly to an end user. This transfer must include all of the software product (including all component parts, the media and printed materials, any upgrades, and this EULA). Such transfer may not be by way of consignment or any other indirect transfer. The transferee of such one-time transfer must agree to comply with the terms of this EULA, including the obligation not to further transfer this EULA and the software product.

**2.5 Termination.** Without prejudice to any other rights, MacroExpressions may terminate this EULA if you fail to comply with the terms and conditions of this EULA. In such event, you must destroy all copies of the software product, including version-controlled or otherwise archived copies.

## **3. COPYRIGHT**

All title and intellectual property rights in and to the software product (including but not limited to any software components incorporated into the software product), the accompanying documentation, and any copies of the software product are owned by MacroExpressions or its suppliers. All title and intellectual property rights in and to the content which may be accessed through use of the software product is the property of the respective content owner and may be protected by applicable copyright or other intellectual property laws and treaties. This EULA grants you no rights to use such content. All rights not expressly granted are reserved by MacroExpressions.

## **4. EXPORT RESTRICTIONS**

The software product software, including examples and documentation, may be subject to U.S. export control laws, including the U.S. Export Administration Act and its associated regulations, and may be subject to export or import regulations in other countries. Customer agrees to comply strictly with all such regulations and acknowledges that it has the responsibility to obtain licenses to export, re-export, or import the software product.

## **MISCELLANEOUS**

This EULA is governed by the laws of the Commonwealth of Massachusetts.

LIMITED WARRANTY. MacroExpressions warrants that (a) the software product will perform substantially in accordance with the accompanying written materials for a period of ninety (90) days from the date of receipt, and (b) MacroExpressions will make commercially reasonable efforts to solve any problem. To the extent allowed by applicable law, implied warranties on the software product, if any, are limited to ninety (90) days.

CUSTOMER REMEDIES. MacroExpressions' and its suppliers' entire liability and your exclusive remedy shall be, at MacroExpressions's option, either (a) return of the price paid, if any, or (b) repair or replacement of the software product that does not meet MacroExpressions's Limited Warranty and that is returned to MacroExpressions with a copy of your receipt. This Limited Warranty is void if failure of the software product has resulted from accident, abuse, or misapplication. Any replacement software product will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer. Outside the United States, neither these remedies nor any product support services offered by MacroExpressions are available without proof of purchase from an authorized international source.
